

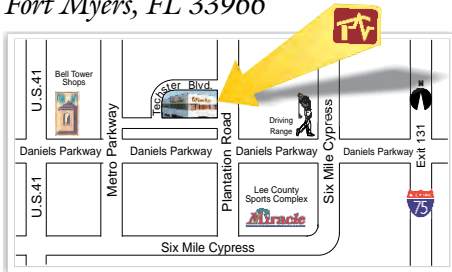
Rules & Intentions

4. All "Agents" must have a signed "Referral Agreement" on file which states all terms and conditions of the Referral Program. Program will be administered according to all State and Federal laws.

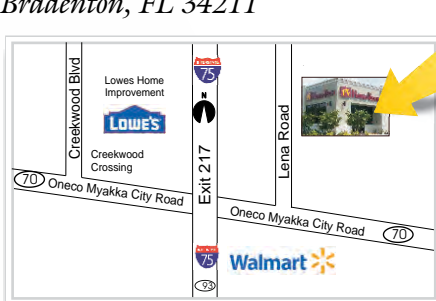
